CONSIDERATION OF THE POSSIBILITY OF
ISSUING A YEARBOOK

Note by the Secretary-General

1. At its twenty-third session the General Assembly adopted on 18 December 1968 resolution 2421 (XXIII) on the report of the United Nations Commission on International Trade Law. In paragraph 6 (f) of this resolution the General Assembly recommended that the United Nations Commission on International Trade Law should "consider, when appropriate, the possibility of issuing a yearbook which would make its work more widely known and more readily available".
2. The Sixth Committee's report relating to this subject reads as follows:
"Several representatives deemed it desirable that UNCITRAL should issue a Yearbook similar to that of the International Law Commission. Most representatives, however, agreed that there was no need for the Sixth Committee to take a decision on the matter at this time and that it was for UNCITRAL to determine the desirability of such a step." 1/
3. The publication of the International Law Commission Yearbook mentioned above was decided by General Assembly resolution 987 (X) of 3 December 1955. The publication started in 1956. As the first session of the Commission was held in 1949, it was decided that for the first seven sessions of the Commission (1949 - 1955), and in view of the backlog of documents to be edited and printed, studies, special reports, principal draft resolutions and amendments presented to the Commission would be published in their original languages only and the summary records of the Commission initially in English. As from 1956 English, French and Spanish editions of the Yearbook have been published.

4. The International Law Commission's Yearbook is divided into two volumes. Volume I contains the summary records of the session. These summary records include the corrections to the provisional summary records which have been made by members of the Commission and such drafting and editorial modifications as are considered necessary; in particular, working papers submitted during the session are incorporated in the summary records. Volume II contains reports submitted by Special Rapporteurs, studies and reports prepared by the Secretariat and comments submitted by Governments. It also contains the report of the Commission to the General Assembly, although this report is issued first as a supplement to the Official Records of the General Assembly, as is the case with the UNCITRAL report.

5. If the Commission wishes to follow the pattern of the International Law Commission's Yearbook for an UNCITRAL Yearbook, an indication as to the form and contents as well as the approximate size of such a publication is to be found in the Annex to the present document, which contains a preliminary outline of the contents of a possible Yearbook for 1968 and 1969. The Commission, of course, might wish to alter the contents indicated in the Annex either by adding or deleting certain documents.

6. Should a proposal be made formally for the publication of the Yearbook, some extra expenditure would follow and a statement of financial implications, in accordance with the financial regulations of the United Nations, would be published at a later date.
