

EXTERNAL VISITORS

Researchers and students may access the UNCITRAL Law Library as external users.

To obtain permission to access the library, external users should indicate their subject of research, intended days of visit and contact information using the contact form available on the UNCITRAL website.

After security clearance, a daily library pass will be issued to the applicant at VIC Gate 1 upon presentation of a picture ID. The pass is valid to visit the UNCITRAL library premises only; misuse (e.g. visiting other areas in the VIC without permission) will result in the withdrawal of permission.

ABOUT US

The UNCITRAL Law Library is the specialized trade law library of the United Nations. It was established in 1979 in Vienna as a reference and research library for the UNCITRAL Secretariat and participants in intergovernmental meetings convened by UNCITRAL. Since its establishment, the Library also supported the research needs of permanent missions, other Vienna-based international organizations, researchers and law students.

The Library has a growing collection of books, journals, electronic and multimedia resources on international trade law in the six official United Nations languages, with a special focus on


- international private law

UNCITRAL BIBLIOGRAPHY

The UNCITRAL Law Library prepares an annual compilation of bibliographic references to recent books, articles and dissertations in a variety of languages discussing the work of UNCITRAL.

The bibliography is published yearly as a Commission document. It is also published on the UNCITRAL website and reproduced in the UNCITRAL Yearbook.

LOAN REGULATION

Loans can be made to staff members with a permanent or fixed-term contract of at least one year and to representatives of the Permanent Missions to the United Nations Offices in Vienna.

Other Library patrons should use Library materials in-house.

Monographs and periodicals may be loaned for two weeks, with a possibility of extension. Reference materials should be consulted in the Library premises.

Book drops are located next to the front door of rooms E0423 and E0441 for your convenience.
